## ENVIRONMENTAL POLICY STATEMENT

Our Environmental Policy will also include the following practical objectives: -

1. The conservation of resources, particularly those which are scarce or non renewable.  
This includes: -
  - a) The avoidance of waste by re-using and recycling materials
  - b) The preservation, restoration and enhancement of the built and natural heritage.
  - c) Encouraging the sustainable use of the land based resources and certified timber and wood products.
2. A general reduction in air, land and water pollution.
3. Ensuring that all vehicles and machines meet emission standards, where possible using unleaded fuel. All equipment will also be properly maintained.
4. The use of registered waste disposal companies for removal of all waste streams.
5. Ensuring that any cleaning agents that are used are of a biodegradable nature and that any chemicals do not present an environmental hazard.
